

These are an account admin fee of \$2.00 per month (other payment frequencies may be available) and a one-off establishment fee of \$396.35. Typically, this fee can be paid upfront or, as in this calculation, be capitalised over the contract term, ie. included in the loan amount. These fees can vary per lender and other non-mandatory fees and charges may also apply. The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$162.30 which equals \$33,758.93.
