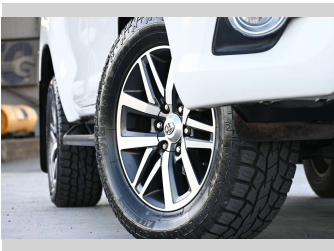

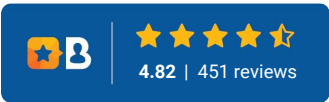

The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$209.57 which equals \$43,590.63.
